## INTRODUCTION

Resolution of commercial disputes and the cost of litigation impose considerable burden on firms and their current and future business relationships. Studies reveal that litigation and related costs have become unsustainably high and figure among the top expenditure on the corporate balance sheet. Effective management of dispute and use of alternative dispute resolution mechanisms such as arbitration, conciliation, and mediation provide the disputing parties control over the dispute settlement process and reduce cost without



imposing undue strain on business relationships. Mediation and conciliation offer the dispute parties a win-win model, findings solutions for disputes while strengthening commercial relationships. Whereas, the adversarial Arbitration process provides parties with an effective and time-bound resolution of disputes.

A robust dispute resolution strategy requires the firms and the professional intermediaries (mediators and arbitrators) a comprehensive understanding of the options, tools and skillsets for the smooth and effective resolution of the dispute. The **Advanced Programme in Mediation and Arbitration** shall provide the participants with a strategic understanding of the Mediation and Arbitration to enable them to find a sustainable and effective resolution of current and future problems.
